VARIANCE REQUIREMENTS ARE AS LISTED

Residential Setback: 35 ft from Roadway- 15 ft Side & Rear

- 1. A DRAWING OFWHAT'S EXISTING WITH PROPOSED AND THE MEASUREMENT FROM THE PROPOSED STRUCTURE TO THE ADJOINING PROPERTY LINES.

 ROADWAYS: 16 ½ ft from center of roadway, then add the appropriate setback.
- 2. IF THE MEASUREMENT SHOWS YOU ARE NOT WITHIN THE REQUIRED SETBACK OF THE AJOINING PROPERTY OWNERS, YOU WILL NEED THE FOLLOWING:
 - A. THE DRAWING ALONG WITH A BRIEF DESCRIPTION OF THE EXACT AMOUNT OF ENCROACHMENT TO THE AJOINING PROPERTY OWNER OR OWNER'S, FOR WHICH YOU ARE REQUESTING THE VARIANCE FROM.
 - B. ALSO ON THE DRAWING WITH THE DESCRIPTION YOU WILL NEED NOTARIZED SIGNATURES OF ALL AJOINING PROPERTY OWNERS THAT WILL BE EFFECTED BY YOUR VARIANCE REQUEST, THIS INCLUDES ALL SIGNATURES THAT APPEAR ON EACH OF THE PROPERTY OWNER'S DEEDS.
 - C. THIS REQUEST MUST THEN BE PLACED ON THE AGENDA OF A TOWNSHIP SUPERVISOR'S MEETING FOR APPROVAL.
 - D. IF APPROVAL IS OBTAINED, A LETTER WILL THEN FOLLOW FROM THE TOWNSHIP SUPERVISORS OFFICE STATING SUCH APPROVAL.

 EACH PROPERTY OWNER INVOLVED WILL NEED TO RECORD A COPY OF THE APPROVED VARIANCE, AND REFERENCE THEIR DEED NUMBER.

 YOU WILL NEED TO KEEP A RECORDED COPY WITH YOU DEED.
 - E. YOU WILL THEN NEED TO APPLY FOR A PERMIT THRU THE TOWNSHIP OFFICE, FOR THE ABOVE REFERENCED PROJECT.

THIS WILL BECOME A LEGAL PORTION OF YOUR DEED.
